 - b), , District Councillor Jo Wild and PCSO A Boswell sent apologies. PDNPA member Kath Potter briefly attended to note HGV issues but left without hearing planning comments. County Councillor Jason Atkin attended the meeting with the DDDC conservative candidate for the May election and noted that the DCC advisory HGV signage for Darley Bridge proposals are due out at the end of March.

 - ii) Applications for Decision NP/DDD/1218/1134 Stanton Old Hall Congreave Demolition and replacement of existing link building. Alterations to and change of use of existing buildings to create holiday, bed and breakfast, and office accommodation. Construction of underground plant room, tractor store, waste treatment plant, and ground source heat pump. Alterations to site access. Landscaping and other works incidental to the proposed development

Council cannot support this application as it stands for the following reasons:

It is considered that this proposal would be against the Core Strategy which does not allow for businesses in existing isolated buildings, or new buildings in the open countryside in order to conserve landscapes and valued characteristics such as tranquillity and dark skies. The Development Plan seeks to steer new business development to settlements rather than the countryside, council believes that Congreave would not be classed as a settlement.

Council regrets the neglect over past years having brought about the need for large scale renovation but feels the application and it's change to commercial business use is not appropriate for this significant building. It does, however, note that the planning officer's recommendation in the D&A Statement, for siting the new plant room on the

ground floor of the barn, would limit use of this space for business purposes and therefore cap the usage and footfall should this aspect be approvable.

The major problem of access is of most concern. The route uphill from the Hall to Pilhough crossroads is extremely narrow and the junction already dangerous. There are very few passing places and whilst the improvements to the hall access are welcomed the major problems are with the remainder of the route. This is a narrow 60mph country lane route very heavily used by walkers – especially DofE groups and a substandard road. Increased traffic will conflict with local usage and lost HGVs and the potential from B&B, 2 holiday cottages and a business will increase the number of journeys. It is noted that the HSP report published has lots of missing statistics, is generic and does not take any account of local knowledge of true accident and incident statistics. DCC Highways statement of 13th April noted the negative effects due to the significant intensification of traffic in the development of this site and unless they propose significant improvement to the lane – their report was not yet available at the time of this decision, Council considers this a major obstacle for the scale of this application.

NP/DDD/1218/1142 Stanton Old Hall Congreave (details as per 1134)- Listed Consent The Parish Council supports the PDNPA Conservation Officers views regarding all listed aspects of this application.

iii) Planning updates/issues:

Tonnage - tonnages have been notified to us with few movements currently

The Cottage Congreave – still no sign of remedial works

Beighton Lodge – parking infringements continue and no response on the light pollution query from PDNPA – the owner has offered to meet with Councillors

Highways: HGVs – 3 more cought on Rowsley/ Stanton Lees section. The wall in Congreave is being rebuilt for the third time in 18 months due to HGV damage.

Pilhough crossroads – the diverted water run off inspection this week

Stanton Road run off – no response from officers

Trees on Lees Road above the Stanton Lees Chapel still awaiting attention
