A member of the public discussed the Enthoven EA appeal and his optimism for limits not being raised but awaits the verdict and noted the already incremental increases since 2006 and a double-sided insert to Snail for parishioners to support an action group. A new variation of the EA permit was applied for June/July last year but details await the formal application period for release of a copy so were not available for this meeting. The lack of consultation gives grounds for challenge at many levels as this is a Schedule 1 site and the outcome of the appeal is awaited to set this in motion. Swings – the clerk has had two similar prices for purchase and one for fitting which with the wet pour patch doubles the cost. Further prices will be sought but play companies do better package deals than individual items which will impact reserves while grants are unavailable.

ii. PDNPA Stanton Moor Meeting

The next is on 1st April and with the poor response from DDDC on PSPOs but further interest shown by our MP it is hoped there will be more to report to parishioners in Snail.

- iii. PDNPA Minerals Meeting is on 24th March and thanks to Jane Newman the PDNPA lead who is leaving the authority will be passed on. Noise at New Pilhough has increased in the last few days and will be queried.

South Darley Council will be asked about the resumption of Liaison meetings once the appeal decision is received.

- v. Local Boundary Commission changes Responses to this will be made by 10th April deadline. Currently is proposed that the Stanton District Ward loses Rowsley to Chatsworth and gains South Darley.

SEG have been awarded a grant incorporating two octagonal picnic benches that are easier to sit at. Council is pleased to accept these assets and add to our register as they to be placed on The Green and available year round for any parishioner and visitor to use.
